Tier	Annual Case Volume	Rebate Amount
1	1-25	\$2.00 per 20 lb. case
2	26-100	\$2.50 per 20 lb. case
3	101+	\$3.00 per 20 lb. case

- CraveMail subscribers get an additional \$1.00 off per 20 lb. case and \$0.50 per 10 lb. case.
- Rebate value for 10 lb. cases is half that of a 20 lb. case at each tier (\$1.00 for cases 1-25; \$1.25 for cases 26-100; \$1.50 for cases 101+).
- Each 10 lb. case counts toward half of a case for annual volume calculation.
- Case count cumulates over the annual promotional period (6/1/2023 – 5/31/2024) to determine rebate tier.

Maximum annual rebate of \$5,000 based upon total annual volume. To qualify for rebate, purchases must be made between June 1, 2023 and May 31, 2024 (Promotional Period). During the Promotional Period, operators will receive \$2 off per 20lb case for first 0-25 cases; then \$2.50 off per 20lb case for 26-100 cases; then \$3 off per 20lb cases for 101+ cases, up to \$5,000 maximum. Operators will receive \$1 off for each 10lb case; every 2 10lb case purchases counts as 1 case towards the 20lb tiers. CraveMail subscribers are eligible to receive an extra \$1 off per 20lb case or an extra \$0.50 off per 10lb case, up to \$5,000 maximum rebate.

Rebates will be issued quarterly following the end of each Purchasing Period (August 31, 2023; November 30, 2023; February 28, 2024; May 31, 2024). To qualify for the CraveMail added incentives, operator must be signed up for CraveMail during the respective quarter of the Promotional Period. Rebate forms must be postmarked by the submission date to receive quarterly payment (September 30, 2023; December 31, 2023; March 31, 2024; June 30, 2024). One quarterly rebate per location. Allow 6-8 weeks for receipt of quarterly rebate following the end of each Purchasing Period.
